Event Rules

There will be Four (4) Divisions Horse, Pair, Pony and VSE

Open and Novice classes will be offered in each division.

Novice entries walk or trot only, helmets required. Navigators required unless equine is VSE less than 99 cm or small pony less than 120 cm.

Open entries any gait, helmets required. Navigators required unless equine is VSE less than 99 cm or small pony less than 120 cm.

If conditions allow, there will be two runnings of the Derby, one in the morning that begins at 9:00 AM and one that begins at approximately 2 PM.

If there are two runs the best of two times will be used for placings.

There will be a prize for first, second, and third placings in each class.

Stalls will be available for \$30.00 per night. Stalls to be cleaned prior to leaving facility or leave a donation.

RV Hookup will be available for \$40 per night.

Concessions will be available.

Driving in the arena prior to the competition is at the discretion of our official.

TCA Pinch Hitcher Driving Derby Liability Release

This form must be signed by every Competition participant or if a minor, their consenting parent, including each person who rides with a driver on a carriage not only during the actual Competition but including any time from arrival at the Competition to departure. I understand and agree that neither the Tejas Carriage Association nor the Houston Area Carriage Assoc and its officers, the Driving Event Competition ("Competition"), Competition judges, officials, workers, volunteers or organizing committee nor the property owners accept or shall have any responsibility of any nature whatsoever for accidents, damage, injury or illness to the horses, owners, riders, drivers, grooms, passengers, attendants, spectators or any other person or property in connection with this Competition. I hereby expressly agree without any limitation or condition for myself and my principals, representatives, employees and agents: (1) to be bound by the rules and by-laws of TCA and HACA and any local rules of this Competition; (2) that every horse, driver, attendant, groom and/or passenger is eligible as entered; and (3) to accept as final any decision of the Competition officials on any question arising under the rules and by-laws or any local rules of the Competition. I also agree, without any limitation or condition, to hold TCA and/or HACA, its officers, directors, employees and agents, and Competition judges, officials and organizing committee, harmless from any and all liability, loss, claims or actions, causes of action, judgments or demands of any nature whatsoever. I am fully aware and appreciate that equine sports, including driving in this particular Competition involve inherent dangerous risk of serious injury or death. By participating I do so voluntarily and expressly assume any and all risks of injury to me or loss of my horse(s) or equipment. I agree to release and voluntarily waive the right to sue the TCA and/or HACA, its officers, directors, employees, and agents, stewards, Competition judges, personnel, volunteers, officials, and organizing committee, including their agents and employees from and against all claims for damages, including money damages, for any action taken or otherwise any harm caused by me or my horse to others, including whether arising from directly or indirectly from the negligence of the TCA and/or HACA or the Competition. I agree to indemnify and hold harmless TCA and/or HACA, its officers, directors, employees, clinicians, members, volunteers, coaches, representatives, assigns, Competition judges, official and organizing committee, their agents and employees from any and all claims for loss or injury caused by me or my horse that occur during or in conjunction with this Competition. I also agree that as a condition of and in consideration of acceptance of entry, the TCA, HACA and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts or Internet, film, new media or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition, sport, or the TCA and/or HACA BY SIGNING BELOW, I AGREE to be bound by all applicable TCA and /or HACA rules and all the terms and conditions of this AGREEMENT.
